## **CALL TO ORDER:**

## ADOPTION OF COUNCIL RULES OF ORDER AND PROCEDURES:

Mayor Myers stated that the proposed version of the Council Rules of Order and Procedures was before them and called for a Motion to adopt.

Motion was offered by Councilman Hinchie and Seconded by Councilman Stone to adopt the Rules of Order and Procedures as presented. Motion carried with seven members of the Council voting in favor, one absent (Combs).

## **ELECTION OF DEPUTY MAYOR:**

Mayor Myers called for nominations for the position of Deputy Mayor for the ensuing one-year term.

Motion was made by Councilman Stone and Seconded by Councilman Leuther to nominate Councilwoman Nelson as Deputy Mayor.

The Mayor called for a vote to the Motion on the floor. Motion carried with seven members of the Council voting in favor, one absent (Combs).

## COUNCIL CONCERNS:

Councilman Stone shared updates from the Historic Preservation Commission regarding the upcoming meeting on April 17. He also expressed gratitude to the Solid Waste department for their cleanup efforts and extended thanks to the citizens.

Councilman Leuther reported no Airport Advisory Board meeting updates since the last report. He echoed Councilman Stone's gratitude and mentioned the recent YMCA banquet. Additionally, Leuther encouraged support for their pool project and proposed discussing youth initiatives in a future work session.

Councilman Combs was absent.

Councilman Washington had no concerns to share. He asked Parks & Recreation Director Caswell to give a quick review of information shared at the Park Board meeting. Caswell spoke of the removal of dead trees by park workers and ongoing efforts to develop a corporate membership plan. Washington also expressed appreciation for the voters in the 4th ward and thanked them for their support.

Myers requested City Engineer Kyle Bruemmer to provide details about the recent mailing. Bruemmer explained that the engineering department has initiated a survey to residents in a specific area to support a grant application for a storm tunnel replacement project. The survey, which is anonymous, is exclusively for the grant application process. It's important to note that the survey is not distributed to students. However, increasing the number of responses enhances the likelihood of securing the grant. This survey was developed by the Office of Economic Development and has no identifiable information. The project is estimated around 1.1 million and the hope is to lessen the storm tax dollar burden while efficiently utilizing grant funding.

Director Doyle expressed gratitude to the citizens for their participation in the election. She emphasized her passion for civic engagement and the importance of voting. Doyle thanked those who supported the city ballot initiative and commended everyone for their diligence in researching and understanding the issues. She expressed appreciation for the passage of the tax and highlighted the potential it offers to accomplish more with the allocated funds.

# Resolution 3535: TAP Grant Sidewalk and Stormwater Improvements

A Resolution authorizing the Mayor, on behalf of the City of Fulton, Missouri, to file and sign all necessary documents in relation to an application for the Missouri Department of Transportation (MODOT) Transportation Alternatives Program Grant to make improvements on Business Highway 54 between Fulton High School and Meadowlark Lane.

Motion was made by Councilwoman Nelson and Seconded Councilman West to adopt Resolution 3535 at tonight's council meeting. Motion carried with seven members of the Council voting in favor, one absent (Combs).
