Purchase of American Made Products

The City of Fulton supports the purchase of American made products. Bidders are hereby notified that the City of Fulton shall adhere to the following policy:

- a) Where the cost of an individual product exceeds \$500.00, preference will be given to products manufactured, assembled or produced in the United States when the quality and price are comparable with other goods.
- b) Every contract for public works construction or maintenance in excess of \$1,000 shall contain a provision to use American products in the performance of the contract whenever the quality and price are comparable with other goods.

Withdrawal of Bids

Any bidder may withdraw his bid at any time prior to the scheduled time for termination of the bidding. No bidder may withdraw his bid for a period of thirty (30) days after the scheduled time for termination of bidding.

Rejection of Bids

The owner reserves the right to reject any or all bids and to waive any informalities in the bidding. The owner does not obligate himself to accept the lowest or any other bid nor to award or make the purchase in any definite time.

Each bidder must deposit with his bid, security in the amount, form and subject to the conditions provided in the Information for Bidders.

The minimum of the State Prevailing Wage Requirements for the project area shall be paid for all crafts used on the project if the project cost exceeds the amount of \$75,000.00.
